5. If elected, what are your top three priorities for 2019-2020?

Answer: <u>Education Improve business operation</u> <u>environment Crime</u>

6. Do you support the continued use of bona fide independent contractors in the trucking industry and oppose efforts by state and local governments to reclassify owner-operators as employees? **Answer: <u>Yes</u>**

11. Currently, both the Department of Transportation and the Department of Public Safety have law enforcement officers that specialize in commercial vehicle enforcement. Do you believe Arizona should look at consolidating all truck enforcement activities under the Department of Public Safety? **Answer:** <u>No, I do not believe we should consolidate</u> <u>ADOT's law enforcement under DPS.</u>

Comments: <u>AZ DPS should not be the only law</u> <u>enforcement in the state. The present</u> <u>administration wants DPS to take over many other</u> <u>investigative areas in the state as well.</u>

Given the importance of transportation is to our economic success, how would you propose we solve the revenue shortfall needs for transportation? **Answer: I would want to reduce taxes to business before raising them. We could tax gasoline only, raise light vehicle diesel taxes but I would like to avoid raising the tax exposure of the trucking industry.**
