Arizona's 2024 Truck Driving Championships (TDC) will be held **Saturday, April 13<sup>th</sup>** at the Tempe Diablo Stadium 2200 West Alameda Drive Tempe, AZ 85282

### **To Register Please Follow the Instructions Listed Below:**

1. Use the application included in this file or download the current version on our website:

Complete both pages:

- a. Form TR-1 -Truck Driving and Step Van Championships "**Driver Entry and Release**"
- b. Form TR-2 - Truck Driving and Step Van Championships "**Driver Registration**"

A current copy of driver's MVR within the past 120 days showing driver name and class of CDL must be included in the application.

- i. CDL exception for step van applicants -they must still have MVR
- ii. MVRs are available at the ATA Vehicle Registration Department

2. **All forms required to register must be completed in their entirety.**

**Forms must be signed by both the Employer Manager and the Driver.**

*(Note: the information on the right-hand side of form TR2 with the exception of address, phone number and email is used by the announcer. Please fill in as much information as possible. Address, phone number and email will be used to communicate with class winners and is required.)*

3. Completed applications must be submitted to the Association office at 7500 W. Madison Street Tolleson, AZ 85353 with the registration fee of **\$150.00** per driver **no later than 4:00 P.M. - March 29, 2024.**
4. In fairness to all competitors, there will be NO exceptions to the application submittal deadline. **No refunds will be issued after March 29, 2024.**

Prior to submitting applications, please ensure that your company is a member in good standing with the Association, with no unpaid dues or other outstanding invoices. You may contact our Accounting Manager, Karen Schiefelbein, at 602.850.6004 to arrange payment of outstanding invoices.

**To be eligible to enter, the professional truck driver must:**

1. You must have an accident-free record from the day immediately following the 2023 Truck Driving Championships (April 1, 2023) through April 13, 2024, the date of the 2024 Championships.
2. Meet the driver medical qualifications of the U.S. Department of Transportation and hold a CDL (exception for step van drivers), as set forth in 49CFR 391.41.
3. Be continuously employed by the entering employer company for at least 12 months prior to entry and have driven and performed the duties of a professional truck driver for 11 of the 12 months of employment.

The "2024 Facts for Drivers" book and AZ / ATA patches will be distributed to companies as applications are received. One book and one patch per applicant.

One AzTA pin will be distributed to the drivers during the registration process on April 13<sup>th</sup>.

- All first-place winners of this year's TDC who remain eligible will represent Arizona in the National Truck Driving Championships in Indianapolis, Indiana.
- It is the responsibility of the driver's company to pay all costs involved, including the driver's entry fee to the national competition.

**Returning this year:**

AZ trading pins and souvenir hats will be sold in addition to raffle tickets for great prizes including the 50/50 Raffle. Cash or credit card will be accepted for the raffle items on display. No ATM's are available so please bring cash or a credit card for your purchases.

**New this year- the 50/50 Raffle will be all online. No cash sales will be available for the 50/50 Raffle only. The winner will be given a check for the raffle amount after a photo ID and IRS form W-9 have been completed. You do not need to be present to win the raffle!**

No scores will be displayed during the skills driving portion. Colored flags will be used in each problem.

**Red Flag** = competitor did not score for the problem

**Green Flag** = competitor scored for the problem
